**ORDER**

**WHEREAS**, in terms of Section 14(1) of the NCTE Act,1993, **Chirag Fulia Social Welfare Organisation, Plot No.-15, St/Rd.-Godownpara, Vill/Town/City-Godownpara, P.O.-Santipur, Tehsil/Taluka-Santipur, Town/City-Santipur, Dist.-Nadia, West Bengal-741404** has applied for grant of recognition to **Kabi Kritibas B.Ed. College, Plot No.-736,737,853,854,855, Vill.-Natapuli, P.O.-Gangsara Majhergram, Tehsil/Taluka-Chakdaha, Town/City-Chakdaha, Dist.-Nadia, west Bengal-741233, APP1652** for **B.Ed** course Application dated **29.12.2012** for One year duration under section 14(1) of the NCTE Act, 1993 and hardcopy received by Eastern Regional Committee of NCTE on **03.01.2013**.

**AND WHEREAS**, on scrutiny of the application submitted by the institution, the documents attached therewith, the affidavit submitted and the report received from VT and videography, and the certificates received from the university, the Committee is satisfied that the applicant fulfils the requirements under the provisions of NCTE Act, Rules and relevant Regulations including the Norms and Standards for the said teacher education programme such as instructional facilities, infrastructural facilities, financial resources, etc., for running the programme.

**NOW THEREFORE**, in exercise of the powers vested under Section 14(3) (a) of the NCTE Act. 1993, the Eastern Regional Committee, NCTE hereby grants recognition to **Kabi Kritibas B.Ed. College, Plot No.-736,737,853,854,855, Vill.-Natapuli, P.O.-Gangsara Majhergram, Tehsil/Taluka-Chakdaha, Town/City-Chakdaha, Dist.-Nadia, west Bengal-741233** for conducting **B.Ed** programme of two years duration with an annual intake of **100 Students (Two Basic Units)** from the academic sessions 2015-2016 under Clause 7(16) of NCTE (Recognition Norms & Procedure) Regulations, 2014 subject to fulfillment of the following conditions:-

- I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Loan raising against or mortgaging of FDR's shall not be done.
- II. The institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time.
- III. The institution shall make admission only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations 2014.
